LIMITED LIFETIME WARRANTY

In the unlikely event that you receive defective hardware, fabric or mechanical components, repair and/or replacement parts will be made available to you in accordance with our Limited Lifetime Warranty.

COVERAGE UNDER WARRANTY

J Geiger Shading Systems are covered by a Limited Lifetime Warranty (the "Warranty") for manufacturing defects. A manufacturing defect is defined as a flaw in product design, materials or workmanship that causes the product to no longer function under normal use and as intended. The Warranty is only available to the original retail purchaser who owns the product. Defective products will be repaired or replaced within the warranty period. Discontinued items will be replaced with the closest equivalent. Replacement parts may be new, used, repaired, reconditioned, and/or made by a different manufacturer.

THE SOLE REMEDY UNDER THIS LIMITED WARRANTY IS LIMITED TO REPAIR OR REPLACEMENT AT MANUFACTURER'S OPTION. THIS LIMITED WARRANTY IS CONTINGENT UPON YOU CONTACTING YOUR REPRESENTATIVE OR AUTHORIZED DEALER WITHIN THE APPLICABLE WARRANTY PERIOD.

The Warranty is non-transferable, and only applies to delivered product intended for the original window for which the product was ordered.

J Geiger brackets are covered for manufacturing defects for as long as the original retail purchaser owns the product. The warranty period for motors and related accessories is limited to 5 years from the date of product receipt. J Geiger Shading agrees to pass through to the original retail purchaser any warranties given by third party vendors in connection with shade fabric to the extent permitted by the terms and conditions of such warranties.

EXCLUSIONS

J Geiger's Limited Lifetime Warranty does not cover:

- Any product or component that fails due to abuse, accident, misuse, alteration, wind, salt air, moisture, pro-longed sun
 exposure, extraordinary use, use which is not intended, improper cleaning, improper operation, Natural Disasters (e.g.
 fire, lighting, flooding, tornados, earthquake, hurricane or event beyond our control), use of incompatible devices or
 accessories, vandalism or normal wear and tear.
- Remote controls and batteries.
- On-site labor costs to (a) review, inspect, or diagnose issues and (b) remove, repair, replace, adjust, reinstall and/or reprogram the product or any of its components.
- Shipping charges.
- Natural materials (e.g. wood, grass, jute, reeds).
- Exterior shades or tension shades designed by Crown Shading Company for J Geiger Shading.
- Improper measurement, installation, or service by third party.²
